## Residential Weatherization Available

PCCEO, Inc. Residential Weatherization Program is now accepting applications from homeowners desiring to have their homes weatherized. The Department of Commerce and Economic Opportunity's purpose for the Residential Weatherization Program is to 1) Create jobs and increase skills and career opportunities for the under/ unemployed; 2) Improve energy efficiency and reduce energy costs in disadvantaged communities; and 3) Stimulate local economies by purchasing supplies from local distributors and manufacturers.

Residential Weatherization Program benefits low-income households and communities and generates an average energy cost savings of \$300 per home each year. Professionally trained weatherization auditors/inspectors perform on-site home energy audits using state of the art equipment to identify out-side drafts, and inspect heating and cooling systems for efficiency.

Weatherization crews seal off air leaks, install insulation, make modifications to (or replace) existing heating systems, and make minor repairs to ensure safety. Once installed, these energy saving measures help reduce heating and cooling costs for years to come.

This program is offered on a first come first served basis. No preference is given to applicants based on age. You may also be eligible for assistance if your income meets the federally estab-

lished income guidelines of an income equal to or less than 60% of the Area Median Income. (Area Median Income or AMI is used to determine eligibility in a variety of state and federal programs.

Service area for the Residential Weatherization Program includes Peoria County with emphasis on zip codes 61602, 61603, 61604, 61605, and 61606. Recipients may receive a maximum benefit of up to \$6,500 (per unit). Qualified applicants must own their home. If it is a multi-family housing complex, the owner, must live in one of the units. Multi-family buildings only apply to buildings with 2-6 units. Mobile homes are not eligible.

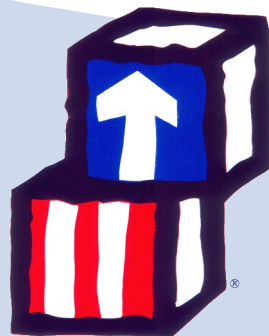

A HUGE thank you to Kent and his family, from Tazewell County, for the wonderful donation of sweet corn. This is the second year that Kent's family has donated this wonderful sweet corn. Last

year they donated 4,206 pounds. This year, they broke the record, bringing in over 3 tons!! It was absolutely flawless. There were 8 pickers at the farm to help pick and they picked all of this corn, by hand, in 2 hours. We are so grateful for this donation. Produce is so very expensive and our pantries were thrilled to be able to receive it.

We have been very busy so far this year---the food bank has distributed over 2,100,000 pounds of food as of the end of June. We hear from our pantries on a daily basis that the distribution lines are getting longer and they see new faces every week. We always ask our pantries to tell their clients to check in on their neighbors to make sure they aren't going hungry. We are concerned about our wonderful seniors and want to make sure they are not doing without the basic necessities, such as food.

Once again, we are extremely grateful for all of our monetary donors, food partners and volunteers. We couldn't do what we do without the support of all involved.
